DP World in Australia have announced they are increasing **Container Infrastructure Access Surcharges** and **Vehicle Booking System (VBS)** surcharges for all containers received or delivered via their DP World Terminals in **Melbourne, Sydney, Brisbane & Fremantle** effective from the **1st of January**. The increases range **up to AU\$58 per container** depending on port of loading/discharge.

Owens Transport in Australia have advised that the cost of dehirng empty containers in **Sydney** will increase. Effective from the **11th of February**, the new **Container Chain (Empty Container Park Fee)** will be **AU\$28 per container**.

Patrick Terminals in Australia have announced they are increasing **Container Infrastructure Access Surcharges** for all containers received or delivered via Patricks Terminals in **Melbourne, Sydney & Brisbane** effective from the **1st of March**. The increases range **up to AU\$15 per container** depending on port of loading/discharge.

PIL has advised that their **Port Service Charge** in **Auckland & Napier** will increase by up to **NZ\$20 per container** for both imports & exports effective from the **1st of March**.
