## Bunker Adjustment Factor Update Low Sulphur Surcharge Update

**ANL** has advised their **Port Congestion Surcharge** for **refrigerated cargo** to **Chittagong** has been withdrawn effective from Bills of Lading dated **1st of July**.

A number of shipping lines (including Hamburg Sud, Cosco, ANL, ONE, OOCL, PIL & MSC) have announced another General Rate Increase (GRI) / Rate Restoration (RR) of up to US\$300 per TEU to be implemented on their services from Asia to New Zealand. As previously advised, the increase will vary depending on origin load port and carrier, and is expected to be between US\$25-250 per TEU effective from the 1st of August.

**CMA CGM** have announced they will implement a **Peak Season Surcharge (PSS)** for **Reefer cargo** from **Europe & Mediterranean ports** to Australia & New Zealand. The PSS will be **US\$300 per Reefer container** effective from the **1st of August** until further notice.

MSC have advised they will increase their Origin Terminal Handling Fee (OTHC) by up to NZ\$5 per TEU effective from the 1st of August.

Hapag have advised they will increase their Australian Import Document Fee by AU\$25 per Bill of Lading effective from the 1st of August.

**Marfret** have advised they will increase their **Origin Terminal Handling Charges** for New Zealand exports effective from the vessel **Bomar Regina v54**.

Hamburg Sud have announced a General Rate Increase (GRI) from the USA & Canada to Australia & New Zealand of US\$150 per TEU effective from the 15th of August.

**CMA CGM** have announced a **General Rate Increase (GRI)** from **East Coast & Gulf Coast USA ports** of load and inland locations routed via said ports to Australia & New Zealand. The intended increase will be **US\$100 per TEU** effective from the **17th of August.**
