# **Service Announcement - 15 July 2021**

#### **GRI Overview**

Global shipping remains constrained with ongoing pressure on the Southeast Asia and China markets. As referenced in <u>previous updates</u>, we believe these effects will continue through August, September and onwards. We have seen further shipping line increases for late July shipments from Asia. FCL shipment increases will be communicated by our teams and vary based on shipping line, container type and origin/destination ports.

We continue to increase LCL and air capacity to supplement supply chain options, and recommend a "multi-mode" approach when considering moving cargo into your desired market.

Mainfreight will implement an LCL GRI for July shipments summarised below. (New Zealand exports to Australia also remain under cost pressure; these increases will come into effect in August).

Empty container parks remain congested, with some lines now imposing strict rules and cost increases depending on de-hire location. Wait times at de-hire parks continue to be problematic. Please work with your local Mainfreight team to understand how this may affect your containers.

### ANL – Update Received 09/07/21 – Auckland

- Re-opening acceptances for Auckland Depots from Monday 12th July across all 20' and 40' equipment types
- This follows a period from Monday 21<sup>st</sup> June to Friday 11<sup>th</sup> July where only Special Equipment & Reefer empties were permitted in the Auckland area
- ANL will continue to accept 40' DRY ST/HC at alternative locations such as Whangarei, Tauranga & Hamilton until Sunday 25<sup>th</sup> July, at which time they will review


### MSC – Update Received 02/07/21

- Mediterranean Shipping Company has advised that containers originating from Australia and discharging in Tauranga with final destination of Auckland or Auckland Metroport, will require equipment to be returned to the Tauranga depot
- Effective the Thursday 8th July, should the client choose to return equipment in Auckland, a Container Drop Off Fee of USD\$1,000 per container will be applicable

### Maersk - Update Received 13/07/21

- Equipment management in Auckland indicates that empty stocks remain high, but depots are open and accepting empty containers. Additional solutions are being developed to mitigate the congestion faced in the market
- Reefer and 20DRY Food Grade units are under strict coordination with Maersk team for all AU & NZ locations.
